INSTALLATION/OPERATING INSTRUCTIONS

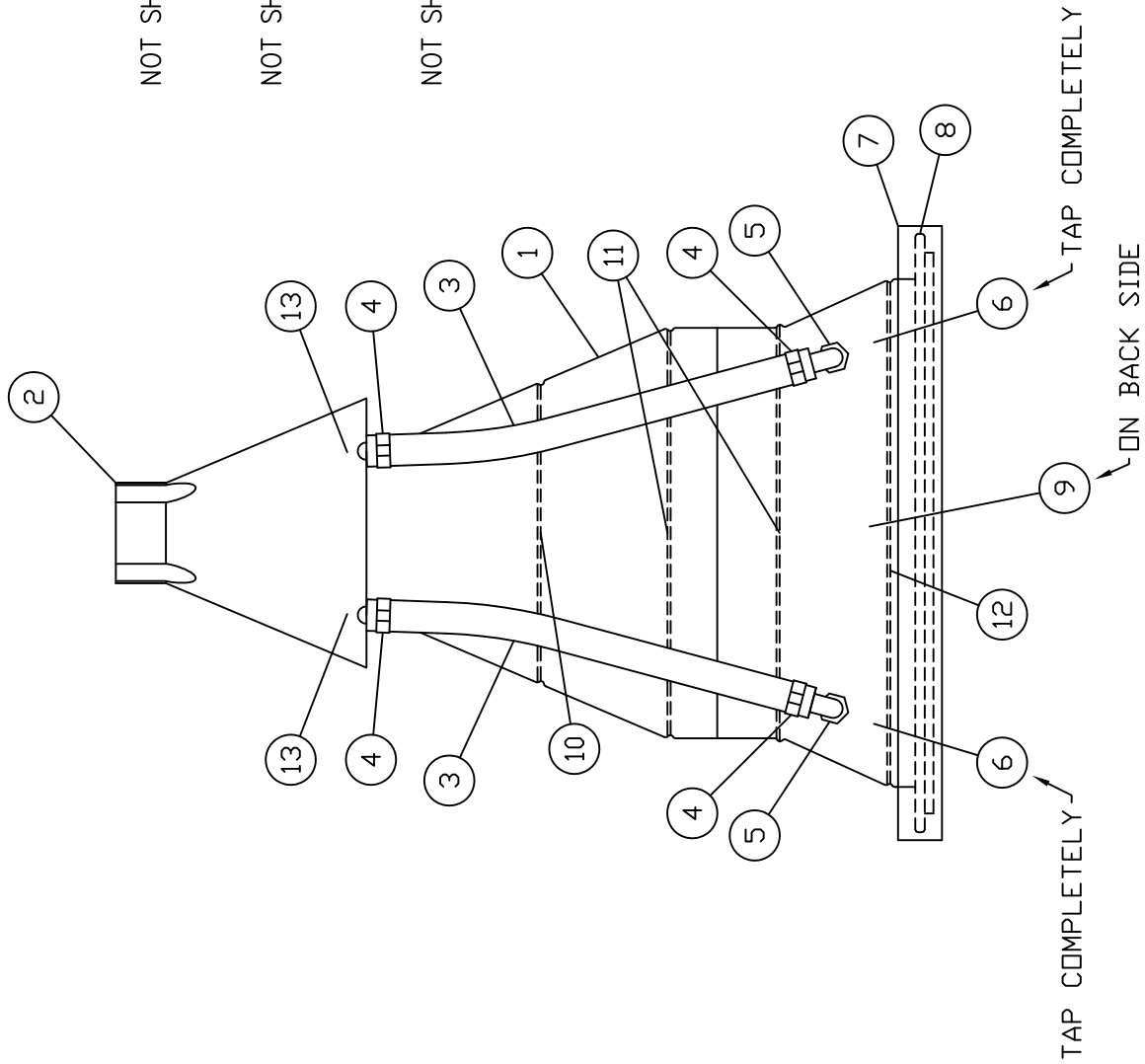
1. Lay a 50-pound bucket of chemical on the floor sideways, roll the bucket around to loosen the chemical.
2. Remove the plastic lid from the 50-pound bucket of chemical, place the Total Dump assembly on top of the 50-pound bucket of chemical. Align the assembly to fit flush on the rim of the bucket.
3. Align the clamp (item 7) around the rim of the bucket and total dump assembly. Fold the clamp lever inward toward the band of the clamp. The clamp should fit tightly around the rim of the bucket and the rim of the total dump assembly. If needed, with the clamp in the closed position, turn the adjustment screw on the clamp lever clockwise until the clamp becomes snug. **DO NOT OVER TIGHTEN.**
4. Place the fill cone (item 2) into the neck of the extinguisher or wheel unit as you invert the bucket upside down. The fill cone must seal fully inside the extinguisher neck to prevent chemical dust from escaping.
