## **DCX-20 OPERATING INSTRUCTIONS**

### **TO LOAD DCX-20**

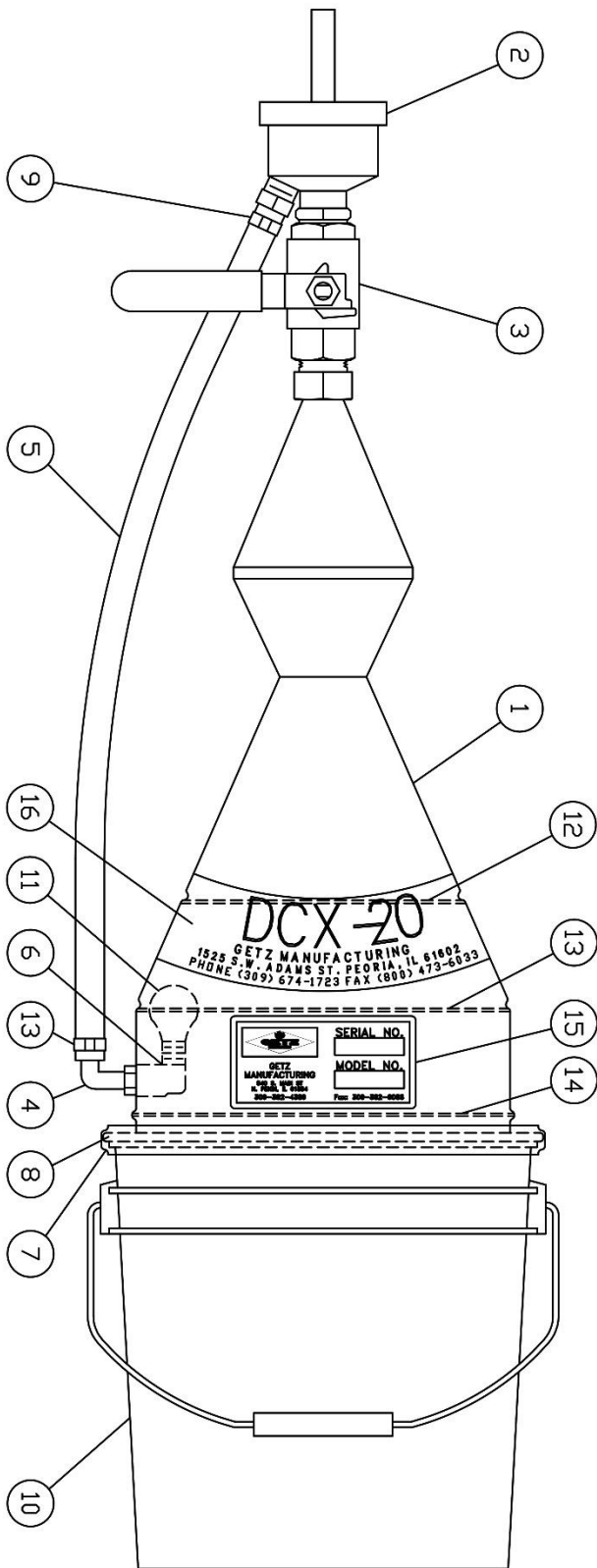
1. Remove DCX “V” clamp from DCX-20.
2. Remove the lid from the chemical pail.
3. Place DCX on top of pail & reattach “V” clamp ring.

*NOTE:* To load the DCX-20 with a 9 kg. or a 20 lb. plastic package of chemical, insert complete package inside the empty pail, draping top portion of package over the rim of the pail.

### **TO FILL A FIRE EXTINGUISHER**

Secure the fire extinguisher to prevent possible toppling, then invert DCX on top of the extinguisher. Open valve. The chemical will flow like a fluid, filling the extinguisher in just seconds! When the extinguisher is full, the chemical will enter the clear lexan tube (in-line with vent return). Close valve. Let chemical settle out of lexan tube.

Now, remove the DCX-20 to an upright position.
